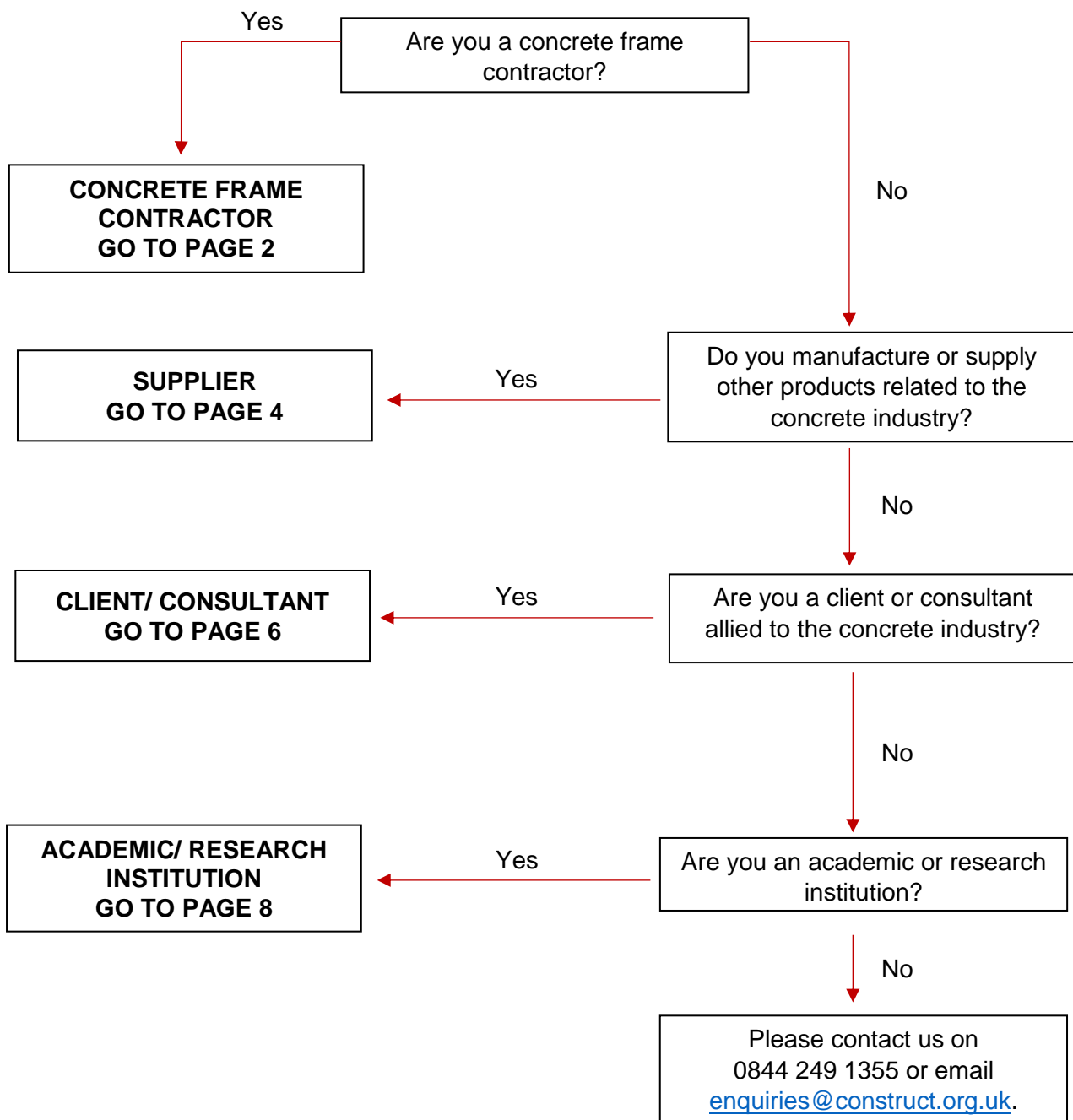


# Membership Application Form
